- (1) These shares represent restricted stock units that were granted to the Reporting Person on May 31, 2017. The restricted stock units vest over a three-year period: 33.33% on the first anniversary of the grant date, 33.33% on the second anniversary of the grant date and remaining 33.33% on the third anniversary of the grant date.
