On October 31, 2018, 4,085,000 shares of the Issuer's Common Stock were transferred from Turquoise Investments Ltd., a Cayman Islands corporation, to James J. Kim. All of the stock of Turquoise Investments Ltd. is owned by Swallow Ltd., a Cayman Islands corporation. All of the stock of Swallow Ltd. is owned by an irrevocable trust created May 10, 1994 of which James J. Kim is the sole beneficiary. The trust was funded by the father of James J. Kim. Turquoise Investments Ltd. and Swallow Ltd. are being dissolved and the trust is being terminated.
