The name of the issuer is Michael Baker Corporation (the "Company").

- (iii) Tontine Overseas Associates, L.L.C., a Delaware limited liability company ("TOA"), which serves as investment manager to certain managed accounts, with respect to the shares of Common Stock directly owned by the managed accounts; and
- (iv) Jeffrey L. Gendell, with respect to the shares of Common Stock directly owned by each of TP and the managed accounts.

The foregoing persons are hereinafter sometimes collectively referred to as the "Reporting Persons." Any disclosures herein with respect to persons other than the Reporting Persons are made on information and belief after making inquiry to the appropriate party.
