The second sentence of Item 3 of the Schedule 13D is hereby amended as follows:

A total of approximately \$25,813,964 was paid to acquire such Shares.

Item 5. Interest in Securities of the Issuer

Paragraphs (a), (c) and (e) of Item 5 of the Schedule 13D are hereby amended as follows:

(a) The Reporting Persons beneficially own 355,176 Shares, constituting approximately 4.9% of the Shares outstanding.

The aggregate percentage of Shares beneficially owned by the Reporting Persons is based upon 7,200,000 Shares outstanding, which is 9,600,000 Shares, the total number of Shares outstanding as reported in the Issuer's Definitive Proxy Statement, filed with the Securities and Exchange Commission on January 30, 2008, minus 2,400,000 Shares tendered pursuant to a tender offer conducted by the Issuer expiring on July 25, 2008, as disclosed in the Issuer's SC TO-I/A, filed with the Securities and Exchange Commission on August 1, 2008.

- (c) Information concerning transactions in the Shares effected by the Reporting Persons during the past sixty days is set forth in Appendix A hereto and is incorporated herein by reference. Unless otherwise indicated, all of such transactions were effected in the open market.
- (e) The Reporting Persons ceased to be the beneficial owner of more than five percent of the Shares on December 2, 2008.
- Item 6. Contracts, Arrangements Understandings or Relationships with Respect to Securities of the Issuer

The third sentence of the first paragraph of Item 6 is hereby amended and restated as follows:

In addition to the Shares that they beneficially own without reference to these contracts, the Reporting Persons currently have long economic exposure to 1,958 Shares through such contracts, and no short economic exposure to any Shares through such contracts.
