This prospectus supplement is not complete without, and may not be delivered or used except in conjunction with, the prospectus, including any amendments or supplements to it. This prospectus supplement is qualified by reference to the prospectus, except to the extent that the information provided by this prospectus supplement supersedes information contained in the prospectus.

- (1) Although the additional holdings of the selling securityholders listed in this prospectus supplement will cause the aggregate principal amount of notes whose ownership is listed in the prospectus dated September 27, 2007 and in related prospectus supplements filed thereafter to exceed \$400,000,000 (the aggregate principal amount of notes outstanding), the aggregate principal amount of notes outstanding has not been and will not be increased. We believe that the excess amount is due to notes that have been sold in transactions exempt from the registration requirements of the Securities Act of which we have not been informed.
- (2) Assumes conversion of all of the holder's notes at a conversion rate of 80.5153 shares of our common stock per \$1,000 principal amount of notes. This conversion rate, however, is subject to adjustment as described under Description of the notes Conversion rights Conversion rate adjustments in the prospectus. As a result, the number of shares of our common stock issuable upon conversion of the notes may increase or decrease in the future. Fractions have been rounded down to the nearest whole share, as no fractional shares will be issued upon conversion of the notes.

In calculating this amount for each holder, we treated as outstanding the number of shares of common stock issuable upon conversion of all of that holder's notes, but we did not assume conversion of any other holder's notes.
