**CryptoLogic subsidiary acquires gaming portal and related assets**

**August 23, 2007 (Dublin, IRELAND, and Toronto, CANADA)** CryptoLogic Limited, a leading software developer to the global Internet gaming market, announced today that its wholly-owned subsidiary, **Gaming Portals Limited (GPL)**, has completed an agreement with leading Internet advertising group Media Corporation plc (Media Corp) to acquire the popular gaming portal *casino.co.uk* and related Internet casino and poker room assets.

This transaction will be earnings accretive from the outset. It is valued at approximately £3 million, with the prospect of an additional payment of £625K subject to achieving post-closing performance targets.
