Contingent Income Auto-Callable Securities with Daily Coupon Observation and 6-Month Initial Non-Call Period (the "securities") offer the opportunity for investors to earn a contingent payment with respect to each observation period during which the closing level of each underlying index is equal to or greater than 75% of its initial index level, which we refer to as its coupon barrier level, on each trading day during the applicable observation period. If the closing level of any underlying index is less than its coupon barrier level on any trading day during an observation period, you will not receive any contingent payment for that observation period. In addition, if the closing levels of **all** of the underlying indices are equal to or greater than their respective call threshold levels on the last day of an observation period (each, an "observation end date") other than the first observation end date and the final valuation date, the securities will be automatically redeemed, as applicable, for an amount per security equal to the stated principal amount plus any contingent payment otherwise payable with respect to the related observation period. If, however, on an observation end date the closing level of any underlying index is less than its call threshold level, the securities will not be redeemed. Furthermore, if the final index level of any underlying index is less than its downside threshold level on the final valuation date, UBS will pay you a cash payment per security that will be less than the stated principal amount, if anything, resulting in a percentage loss that is equal to the underlying return of the underlying index with the lowest underlying return as compared to the other underlying indices (the "worst performing underlying index") over the term of the securities, and in extreme situations, you could lose all of your initial investment. The securities do not guarantee any return of principal at maturity. Investors will not participate in any appreciation of the underlying indices and must be willing to accept the risk of not receiving any contingent payments over the term of the securities. Because all payments on the securities are based on the worst performing underlying index, a decline beyond the respective coupon barrier level and/or downside threshold level, as applicable, of any underlying index will result in few or no contingent payments and/or a loss of a significant portion and, in

extreme situations, all of your initial investment even if each other underlying index appreciated or has not declined as much. These securities are for investors who are willing to risk their initial investment and seek an opportunity to earn interest at a potentially above-market rate in exchange for the risk of receiving no interest over the entire approximately 2.5-year term of the securities. Original issue date: Approximately June 1, 2021, subject to postponement for certain market disruption events and as described under “General Terms of the Securities — Market Disruption Events” and “— Valuation Dates — Final Valuation Date” in the accompanying product supplement.

Maturity date: If, on any observation end date other than the first observation end date and the final valuation date, the closing levels of **all** of the underlying indices are equal to or greater than their respective call threshold levels, the securities will be automatically redeemed for an early redemption amount on the first contingent payment date immediately following the related observation end date.

Early redemption: The early redemption amount will be an amount equal to (i) the stated principal amount *plus* (ii) any contingent payment otherwise payable with respect to the related observation period.

Early redemption amount:

Contingent payment: If the closing levels of **all** of the underlying indices are equal to or greater than their respective coupon barrier levels on each trading day during an observation period, we will pay a contingent payment of \$30.25 (equivalent to 12.10% per annum of the stated principal amount) per security on the related contingent payment date.

If the closing level of **any** underlying index is less than its respective coupon barrier level on any trading day during an

observation period, we will not pay a contingent payment with respect to that observation period.

Observation end dates:

We also refer to May 26, 2021 as the final valuation date. In the event that we make any change to the expected pricing date and original issue date, the calculation agent may adjust the observation end dates (including the final valuation date) and maturity date to ensure that the stated term of the securities remains the same.

Contingent payment dates:

Three business days following the applicable observation end date on which the applicable observation period ends, except that the coupon payment date for the final observation period will be the maturity date.

Observation Period

The first observation period will consist of each day from but excluding the pricing date to and including the first observation end date. Each subsequent observation period will consist of each day from but excluding the prior observation end date to and including the next following observation end date. References in the accompanying product supplement to one or more "valuation periods" shall mean the observation periods for purposes of the market disruption event provisions in the accompanying product supplement.

Payment at maturity:

If the final index levels of **all** of the underlying indices **are equal to or greater than** their respective downside threshold levels:

the stated principal amount *plus* any contingent payment otherwise payable with respect to the securities on the maturity date.

If the final index level of **any** underlying index **is less than** its downside threshold level:

a cash payment that is less than the stated principal amount, if anything, resulting in a percentage loss that is equal to the underlying return of the worst performing underlying index, for an amount equal to (i) the stated principal amount *plus* (ii)

the stated principal amount *times* the underlying return of the worst performing underlying index.

Investment Summary

The Contingent Income Auto-Callable Securities with Daily Coupon Observation and 6-Month Initial Non-Call Period due on or about June 1, 2021 based on the worst performing index among the NASDAQ-100 Index[®], the Russell 2000[®] Index and the S&P 500[®] Index, which we refer to as the securities, provide an opportunity for investors to earn a contingent payment, which will be an amount equal to \$30.25 (equivalent to 12.10% per annum of the stated principal amount) per security, with respect to each observation period on which the closing levels of **all** of the underlying indices are equal to or greater than 75% of their respective initial index levels, which we refer to as the coupon barrier levels, on each trading day during the applicable observation period. The contingent payment, if any, will be payable on the relevant contingent payment date, which is the third business day after the related observation end date. **It is possible that the closing levels of one or more of the underlying indices could remain less than their respective coupon barrier levels for extended periods of time or even throughout the term of the securities so that you may receive few or no contingent payments.**

If the closing levels of **all** of the underlying indices **are equal to or greater than** their respective call threshold levels on any of the observation end dates other than the first observation end date and the final valuation date, the securities will be automatically redeemed for an early redemption amount equal to the stated principal amount plus any contingent payment otherwise payable with respect to the related observation period. If the securities have not previously been redeemed and the final index levels of **all** of the underlying indices **are equal to or greater than** their respective downside threshold levels and the closing levels of **all** of the underlying indices are equal to or greater than their respective coupon barrier levels on each trading day during the final observation period, the payment due at maturity will be the stated principal amount plus the contingent payment otherwise payable with respect to the final observation period. Key Investment Rationale

The securities offer the opportunity for investors to earn a contingent payment equal to at least \$30.25 (equivalent to at least 12.10% per annum of the stated principal amount) per security, with respect to each observation period on which the closing levels of **all** of the underlying indices are equal to or greater than 75% of their respective initial index levels, which we refer to as the coupon barrier levels, on each trading day for the applicable observation period. The securities may be redeemed prior to maturity on any observation end date other than the first observation end date and the final valuation date for an early redemption amount equal to the stated principal amount per security plus any contingent payment otherwise payable with respect to the related observation period. The payment at maturity will vary depending on the final index levels, as follows:

On any observation end date other than the first observation end date and the final valuation date, the closing levels of all of the underlying indices are equal to or greater than their respective call threshold levels.

Scenario 1 The securities will be automatically redeemed for an early redemption amount equal to the stated principal amount *plus* any contingent payment otherwise payable with respect to the related observation period. The related contingent payment will be paid only if all of the closing levels for all of the underlying indices were equal to or greater than their respective coupon barrier levels on each trading day during the applicable observation period.

Investors will not participate in any appreciation of the underlying indices from their respective initial index levels.

The securities are not automatically redeemed prior to maturity and the final index levels of all of the underlying indices are equal to or greater than their respective downside threshold levels on the final valuation date and the closing levels of all of the underlying indices are equal to or greater than their respective coupon barrier levels on each trading day during the final observation period.

Scenario 2 The payment due at maturity will be the stated principal amount *plus* the contingent payment otherwise payable on the maturity date.

Investors will not participate in any appreciation of the underlying indices from their respective initial index levels.

The securities are not automatically redeemed prior to maturity and the final index levels of all of the underlying indices are equal to or greater than their respective downside threshold levels. However, the closing level of at least one underlying index is less than its respective coupon barrier level on any trading day during the final observation period.

Scenario 3 The payment due at maturity will be the stated principal amount.

Investors will not participate in any appreciation of the underlying indices from their respective initial index level and will not receive a contingent payment on the maturity date.

Scenario 4 The securities are not automatically redeemed prior to maturity and the final index level of any underlying index is less than its respective downside threshold level and coupon barrier level.

The payment due at maturity will be a cash payment that is less than the stated principal amount, if anything, resulting in a percentage loss that is equal to the underlying return of the worst performing

underlying index, for an amount equal to the stated principal amount *plus* the stated principal amount *times* the underlying return of the worst performing underlying index.

Investors will lose a significant portion and, in extreme situations, all of their initial investment in this scenario.

In Examples 1, 2 and 3, the closing levels of the underlying indices fluctuate over the term of the securities and the closing levels of the underlying indices are equal to or greater than the hypothetical respective call threshold levels on one of the first eleven observation end dates. Because the closing levels of the underlying indices are equal to or greater than their respective call threshold levels on one of the first eleven observation end dates, the securities are automatically redeemed on the related contingent payment date. In Examples 4 and 5, the closing level of at least one underlying index on each of the first eleven observation end dates is less than its respective call threshold level, and, consequently, the securities are not automatically redeemed prior to, and remain outstanding until, maturity.

In **Example 2**, the securities are automatically redeemed following the third observation end date as the closing levels of **all** of the underlying indices on the third observation end date are equal to or greater than their respective call threshold levels. As the closing levels of **all** of the underlying indices are equal to or greater than their respective coupon barrier levels on each trading day during the first observation period, you receive the contingent payments of § \$18.75 with respect to the first observation period. As the closing levels of all of the underlying indices are equal to or greater than their respective coupon barrier levels on each trading day during the third observation period, you receive an early redemption amount of \$1,018.75, which includes the stated principal amount *plus* the contingent payment with respect to the third observation period.

In this example, the early redemption feature limits the term of your investment to approximately 9 months and you may not be able to reinvest at comparable terms or returns. If the securities are redeemed early, you will stop receiving quarterly contingent payments. Further, although all of the underlying indices have appreciated by 20% from their respective initial index levels on the third observation end date, you only receive \$1,018.75 per security and do not benefit from such appreciation. Examples 4 and 5 illustrate the payment at maturity per security based on the final index level.

In **Example 4**, during each of the first through ninth observation periods, the closing level of **at least one** of the underlying indices is less than its respective coupon barrier level on a trading day during the applicable observation periods. As a result, you do not receive a contingent payment with respect to any of those observation periods. Also, the closing levels of at least one of the underlying indices is less than the call threshold level on every observation end date during the first through ninth observation end dates so the securities are not automatically redeemed prior to maturity. Because the closing levels of **all** of the underlying indices are equal to or greater than their respective coupon barrier levels on each trading day during the final observation period, at maturity you receive the stated principal amount *plus* a contingent payment with respect to the final observation period. Your payment at maturity is calculated as follows:

$$\$1,000.00 + \$18.75 = \$1,018.75$$

In this example, you receive the stated principal amount per security plus the contingent payment, equal to a total payment of \$1,018.75 per security at maturity. Your total return per security in this example is \$1,018.75 (a 1.875% total return on the securities).

In **Example 5**, the closing level of **at least one** of the underlying indices is less than its respective coupon barrier level on a trading day during each observation period throughout the term of the securities and the closing level of at least one of the underlying indices is less than its respective call threshold on every observation end date. As a result, you do not receive any contingent payment during the term of the securities and the securities are not automatically redeemed prior to maturity. Furthermore, because the final index level of one of the underlying indices is less than its applicable downside threshold level on the final valuation date, you are fully exposed to the decline in the worst performing underlying index. Your payment at maturity is calculated as follows:

$$\$1,000.00 + (\$1,000.00 \times \text{Underlying Return of the Worst Performing Underlying Index})$$

$$= \$1,000.00 + (\$1,000.00 \times -60\%)$$

$$= \$400.00$$

In this example, because the final index level of the worst performing underlying index represents a 60.00% decline, you will receive a total cash payment per security equal to \$400.00 (a 60.00% loss on the securities).

If the securities are not redeemed prior to the final valuation date, you may lose a significant portion, and in extreme situations, all of your initial investment. Risk Factors

The following is a non-exhaustive list of certain key risk factors for investors in the securities. For further discussion of these and other risks, you should read the section entitled “Risk Factors” in the accompanying product supplement. We urge you to consult your investment, legal, tax, accounting and other advisors before you invest in the securities.

Risk of loss at maturity. The securities differ from ordinary debt securities in that UBS will not necessarily repay the stated principal amount of the securities at maturity. If the securities are not redeemed prior to maturity, UBS will repay you the stated principal amount of your securities in cash only if the final index levels of **all** of the underlying indices are equal to or greater than their respective downside threshold levels on the final valuation date and will only make such payment at maturity. If the securities are not redeemed prior to maturity and the final index level of **any** underlying index is less than its respective downside threshold level on the final valuation date, you will lose a significant percentage of your principal amount equal to the underlying return of the worst performing underlying index.

Contingent repayment of stated principal amount only at maturity. If your securities are not redeemed prior to maturity, you should be willing to hold your securities to maturity. If you are able to sell your securities prior to maturity in the secondary market, you may have to sell them at a loss relative to your initial investment even if the then-current levels of all of the underlying indices are equal to or greater than their respective downside threshold levels.

You may not receive any contingent payments. UBS will not necessarily make periodic payments on the securities. If the closing level of **any** of the underlying indices on any trading day during an observation period is less than its respective coupon barrier level, UBS will not pay you the contingent payment applicable to such observation period and if this continues for each observation period during the term of the securities, UBS will not pay you any contingent payments during the term of, and you will not receive a positive return on, your securities. Generally, this non-payment of the contingent payment coincides with a period of greater risk of principal loss on your securities.

Your potential return on the securities is limited and you will not participate in any appreciation of the underlying indices. The return potential of the securities is limited to the pre-specified contingent payment rate, regardless of the appreciation of the underlying indices. In addition, your return on the securities will vary based on the number of observation periods for which the requirements of the contingent payment have been met prior to maturity or an early redemption. Furthermore, if the securities are redeemed prior to maturity, you will not receive any contingent payments or any other payment in respect of any observation periods after the applicable contingent payment date, and your return on the securities could be less than if the securities remained outstanding until maturity. If the securities are not redeemed prior to maturity, you may be subject to the depreciation in the level of the worst performing underlying index even though you cannot participate in any appreciation in the levels of the underlying indices. As a result, the return on an investment in the securities could be less than the return on a direct investment in any or all of the index constituent stocks.

§ Greater expected volatility with respect to, and lower expected correlation among, the underlying indices generally reflects a higher contingent payment and a higher expectation as of the pricing date that the closing level of any of the underlying indices could be less than its respective downside threshold level on the final valuation date of the securities. Greater expected volatility with respect to, and lower expected correlation among, the underlying indices reflects a higher expectation as of the pricing date that the closing level of any of the underlying indices could be less than its respective downside threshold level on the final valuation date of the securities. “Volatility” refers to the frequency and magnitude of changes in the level of an underlying index. This greater expected risk will generally be reflected in a higher contingent payment for that security. However, while the contingent payment is set on the pricing date based, in part, on the correlations of the underlying indices and each

underlying index's volatility calculated using our internal models, an underlying index's volatility, and the correlation among the underlying indices, can change significantly over the term of the securities. The correlations referenced in setting the terms of the securities are calculated using our internal models and are not derived from the daily returns of the underlying indices over the period set forth under "Correlation of the Underlying Indices" below. The level of any underlying index for your securities could fall sharply, which could result in the loss of a significant portion or all of your initial investment.

Reinvestment risk. The securities will be redeemed prior to maturity if the closing levels of **all** of the underlying indices are equal to or greater than their call threshold levels on any observation end date other than the first observation end date and the final valuation date and you will not receive any more contingent payments after the related contingent payment date. Conversely, the securities will not be subject to an early redemption when the closing level of **any** one of the underlying indices is less than its call threshold level on any observation end date, which generally coincides with a period of greater risk of principal loss on your securities. The securities could be § redeemed as early as the second contingent payment date, potentially limiting your investment to a term of approximately 6 months. In the event that the securities are redeemed prior to maturity, there is no guarantee that you will be able to reinvest the proceeds from an investment in the securities at a comparable rate of return for a similar level of risk. In addition, to the extent you are able to reinvest such proceeds in an investment comparable to the securities, you will incur transaction costs and the original issue price for such an investment is likely to include certain built-in costs such as dealer discounts and hedging costs.

Credit risk of UBS. The securities are unsubordinated, unsecured debt obligations of UBS and are not, either directly or indirectly, an obligation of any third party. Any payment to be made on the securities, including any repayment of principal at maturity, depends on the ability of UBS to satisfy its obligations as they come due. As a result, UBS's actual and perceived creditworthiness may affect the market value of the securities. If UBS were to default on its obligations, you may not receive any amounts owed to you under the terms of the securities and you could lose all of your initial investment.

Market risk. The return on the securities, which may be positive or negative, is linked to the performance of each underlying index and indirectly linked to the value of the index constituent stocks on each trading day during the term of the securities. The level of each underlying index can rise or fall sharply due to factors specific to such underlying index or its index constituent stocks, such as stock or commodity price volatility, earnings, financial conditions, corporate, industry and regulatory developments, management changes and decisions and other events, as well as general market factors, such as general stock market or commodity market volatility and levels, interest rates and economic and political conditions.

You are exposed to the market risk of each underlying index. Your return on the securities is not linked to a basket consisting of the underlying indices. Rather, it will be contingent upon the performance of each underlying index. Unlike an instrument with a return linked to a basket of indices, common stocks or other underlying assets, in which risk is mitigated and diversified among all of the components of the basket, you will be exposed equally to the risks related to each of the underlying indices. Poor performance by any one underlying index may negatively affect your return and will not be offset or mitigated by the performance of any other underlying index. Accordingly, your investment is subject to the market risk of each underlying index.

Because the securities are linked to the performance of more than one underlying index, there is an increased probability that you will not receive a contingent payment with respect to an observation period and that you will lose a significant portion or all of your initial investment. The risk that you will not receive a contingent payment with respect to an observation period and that you will lose a significant portion or all of your initial investment in the securities is greater if you invest in the securities as opposed to securities that are linked to the performance of a single underlying index if their terms are otherwise substantially similar. With a greater total number of underlying indices, it is more likely that the closing level or the final level of **any** underlying index, as applicable, will be less than its respective coupon barrier level and/or downside threshold level during any observation period or on any observation end date (including the final valuation date). Therefore, it is more likely that you will receive an amount in cash which is worth less than your stated principal amount on the maturity date. In addition, if the performances of the underlying indices are not correlated to each other, the risk that the closing level or the final level, as applicable, of **any** underlying index is less than its coupon barrier level or downside threshold level during any observation period or on any observation end date (including the final valuation date), is even greater.

§ Fair value considerations.

o The issue price you pay for the securities will exceed their estimated initial value. The issue price you pay for the securities will exceed their estimated initial value as of the pricing date due to the inclusion in the issue price of the underwriting discount, hedging costs, issuance costs and projected profits. As of the close of the relevant markets on the pricing date, we will determine the estimated initial value of the securities by reference to our internal pricing models and the estimated initial value of the securities will be set forth in the applicable pricing supplement. The pricing models used to determine the estimated initial value of the securities incorporate certain variables, including the levels of the underlying indices, volatility of the underlying indices, any dividends paid on the index constituent stocks, the correlation among the underlying indices, prevailing interest rates, the term of the securities and our internal funding rate. Our internal funding rate is typically lower than the rate we would pay to issue conventional fixed or floating rate debt securities of a similar term. The underwriting discount, hedging costs, issuance costs, projected profits and the difference in rates will reduce the economic value of the securities to you. Due to these

While the BIO-FINMA does not expressly address the order in which a write-off of debt instruments other than debt instruments qualifying as additional tier 1 capital or tier 2 capital should occur, it states that debt-to-equity swaps should occur in the following order: first, all subordinated claims not qualifying as regulatory capital; second, all other claims not excluded by law from a debt-to-equity swap (other than deposits); and third, deposits (in excess of the amount privileged by law). However, given the broad discretion granted to FINMA as the resolution authority, any restructuring plan in respect of UBS could provide that the claims under or in connection with the securities will be partially or fully converted into equity or written-off, while preserving other obligations of UBS that rank pari passu with, or even junior to, UBS' obligations under the securities. Consequently, holders of securities may lose all or some of their investment in the securities. In the case of restructuring proceedings with respect to a systemically important Swiss bank (such as UBS), the creditors whose claims are affected by the restructuring plan will not have a right to vote on, reject, or seek the suspension of the restructuring plan. Section 897. We will not attempt to ascertain whether any index constituent stock issuer would be treated as a "United States real property holding corporation" ("USRPHC") within the meaning of Section 897 of the Code. We also have not attempted to determine whether the securities should be treated as "United States real property interests" ("USRPI") as defined in Section 897 of the Code. If any such entity and the securities were so treated, certain adverse U.S. federal income tax consequences could possibly apply, including subjecting any gain to a non-U.S. holder in respect of a security upon a taxable disposition of the securities to the U.S. federal income tax on a net basis, and the proceeds from such a taxable disposition to a 15% withholding tax. Non-U.S. holders should consult their tax advisors regarding the potential treatment of any index constituent stock issuer as a USRPHC and the securities as USRPI.

Section 871(m). A 30% withholding tax (which may be reduced by an applicable income tax treaty) is imposed under Section 871(m) of the Code on certain "dividend equivalents" paid or deemed paid to a non-U.S. holder with respect to a "specified equity-linked instrument" that references one or more dividend-paying U.S. equity securities or indices containing U.S. equity securities. The withholding tax can apply even if the instrument does not provide for payments that reference dividends. Treasury regulations provide that the withholding tax applies to all dividend equivalents paid

or deemed paid on specified equity-linked instruments that have a delta of one (“delta one specified equity-linked instruments”) issued after 2016 and to all dividend equivalents paid or deemed paid on all other specified equity-linked instruments issued after 2018.

Based on our determination that the securities are not “delta-one” with respect to any underlying index or any U.S. index constituent stock, our counsel is of the opinion that the securities should not be delta one specified equity-linked instruments and thus should not be subject to withholding on dividend equivalents. Our determination is not binding on the IRS, and the IRS may disagree with this determination. Furthermore, the application of Section 871(m) of the Code will depend on our determinations made upon issuance of the securities. Foreign Account Tax Compliance Act. Legislation commonly referred to as the Foreign Account Tax Compliance Act (“FATCA”) generally imposes a withholding tax of 30% on payments to certain non-U.S. entities (including financial intermediaries) with respect to certain financial instruments, unless various U.S. information reporting and due diligence requirements have been satisfied.
