- Reflects the withholding of shares to satisfy tax payment for Performance Shares paid out under the Company's 2007 Omnibus Incentive Compensation Plan. - Performance stock rights represent the right to receive shares of common stock of the Company, in the event certain performance goals are satisfied.
