The value attributable to these purchase rights, if any, is reflected in the value of the associated shares of Class A Common Stock.

Explanatory Note

At the 2016 Annual Meeting of Shareholders of BBX Capital Corporation (the "Company"), the Company's shareholders approved an amendment (the "Amendment") to the BBX Capital Corporation 2014 Stock Incentive Plan, as amended (the "Plan"), to increase the number of shares of the Company's Class A Common Stock available for grant under the Plan from 1,000,000 shares to 2,000,000 shares. The Company is filing this Registration Statement to register the additional 1,000,000 shares of Class A Common Stock available for grant under the Plan as a result of the Amendment. The Company is also registering hereunder the Preferred Share Purchase Rights associated with each share of Class A Common Stock being registered hereunder.

The securities registered hereunder are of the same classes as the securities of the Company registered under the Company's Registration Statement on Form S-8 filed with the Securities and Exchange Commission (the "Commission") on July 11, 2014 (Registration No. 333-197357) (the "Earlier Registration Statement"). Pursuant to General Instruction E to Form S-8, the contents of the Earlier Registration Statement are incorporated herein by reference, except to the extent supplemented, amended or superseded by the information set forth herein.
