As of the close of business on December 31, 2010, (i) BVF beneficially owned 415,949 shares of Common Stock, including 5,200 shares of Common Stock purchasable upon the exercise of Warrants held by it, (ii) BVF2 beneficially owned 288,046 shares of Common Stock, including 3,583 shares of Common Stock purchasable upon the exercise of Warrants held by it, (iii) BVLLC beneficially owned 1,057,819 shares of Common Stock, including 13,833 shares of Common Stock purchasable upon the exercise of Warrants held by it and (iv) ILL10 beneficially owned 113,347 shares of Common Stock, including 1,550 shares of Common Stock purchasable upon the exercise of Warrants held by it.
