Shares of Common Stock reported herein as of December 31, 2017, include (i) for the Fund, 729,089 shares of Common Stock and options to acquire an additional 20,756 shares of Common Stock, and (ii) for the Account, 145,911 shares of Common Stock and options to acquire an additional 4,244 shares of Common Stock.
