(1) Each share of phantom stock is the economic equivalent of one share of GDP common stock.

The phantom stock vests in increments of one-third on the anniversary date of the grant for three years following the grant. Thus, the reporting person will receive 2,667 shares of common stock of the issuer (or cash equal to the value of common stock on the settlement date, in the sole discretion of the Company) on each of February 12, 2009 and 2010; and 2,666 shares of common stock of the issuer (or cash equal to the value of the common stock on the settlement date, in the sole discretion of the Company) on February 12, 2011, provided the reporting person remains an employee of the issuer on those dates.

(3) Options are exercisable in 1/3 increments annually beginning February 12, 2011.
