CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 32,792,080 shares or 7.8% of the 417,637,697 shares of Ordinary Shares, including American Depositary believed to be outstanding.
