CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 3,625,960 shares or 0.9% of the 426,079,492 shares, including American Depositary Receipts, believed to be outstanding.
