Upside participation rate: 375% to 425%*

Maximum return at maturity: \$600 per security (60% of the stated principal amount)

Barrier value: For each underlying, 60% of its initial underlying value
For each \$1,000 stated principal amount security you hold at maturity:

- If the final underlying value of the worst performing underlying is **greater than or equal to** its initial underlying value: $\$1,000 +$ the return amount, subject to the maximum return at maturity
- If the final underlying value of the worst performing underlying is **less than** its initial underlying value but **greater than or equal to** its barrier value: \$1,000

Payment at Maturity: · If the final underlying value of the worst performing underlying is **less than** its barrier value: $\$1,000 + (\$1,000 \times$ the underlying return of the worst performing underlying)

If the final underlying value of the worst performing underlying is less than its barrier value, your payment at maturity will be less, and possibly significantly less, than the \$1,000 stated principal amount per security. Worst performing underlying: The underlying with the lowest underlying return

Selected Risk Considerations
