- If the final underlying value is **less than** the initial underlying value **but greater than or equal to** the barrier value: \$1,000

Payment at Maturity: · If the final underlying value is **less than** the barrier value: \$1,000 + (\$1,000 × the underlying return)

If the final underlying value is less than the barrier value, your payment at maturity will be significantly less than the stated principal amount of your securities and possibly nothing. Selected Risk Considerations
