**Final barrier value:** For each underlying, 60% of its initial underlying value

**Payment at Maturity:** You will receive at maturity for each security you then hold:

· If the final underlying value of the worst performing underlying is **greater than or equal to** its initial underlying value: \$1,000 + the digital return amount

· If the final underlying value of the worst performing underlying is **less than** its initial underlying value but **greater than or equal to** its final barrier value: \$1,000 + (\$1,000 × the absolute underlying return of the worst performing underlying)

· If the final underlying value of the worst performing underlying is **less than** its final barrier value:

\$1,000 + (\$1,000 × the underlying return of the worst performing underlying)

**If the final underlying value of the worst performing underlying is less than its final barrier value, you will receive significantly less than the stated principal amount of your securities, and possibly nothing, at maturity. **Absolute underlying return:** For each underlying, the absolute value of its underlying return

**Worst performing underlying:** The underlying with the lowest underlying return

### **Selected Risk Considerations**

If the final underlying value of the worst performing underlying is less than its final barrier value, you will lose 1% of the stated principal amount of your securities for every 1% by which the worst performing underlying has depreciated from its initial underlying value to its final underlying value. There is no minimum payment at maturity on the securities, and you may lose up to all of your investment.
