Underlying index: The Dow Jones Industrial Average™ (ticker symbol: "INDU")

Valuation date: April 25, 2022

Maturity date: April 28, 2022

Payment at maturity: For each note you hold at maturity, the \$1,000 stated principal amount *plus* the note return amount, which will be either zero or positive

If a knock-out event occurs: $\$1,000 \times$ the knock-out return

Note return amount:

If a knock-out event does not occur: $\$1,000 \times$ the absolute value of the index return

Knock-out return: 3%

Knock-out event: A knock-out event will occur if the closing level of the underlying index on any scheduled trading day during the observation period is less than the downside knock-out level or greater than the upside knock-out level

Observation period: The period from but excluding the pricing date to and including the scheduled valuation date

Upside knock-out level: 125% to 127% of the initial index level*

Downside knock-out level: 73% to 75% of the initial index level*

Initial index level: The closing level of the underlying index on the pricing date

Final index level: The closing level of the underlying index on the valuation date

Index return: (i) The final index level *minus* the initial index level, *divided by* (ii) the initial index level

* The actual upside knock-out level and downside knock-out level will be determined on the pricing date
