Items 5 and 6 of the Statement on Schedule 13D, as amended from time to time, initially filed by Raphael Recanati, are amended by adding the following paragraphs:

A First Amendment to the Amended and Restated Stockholders Agreement, by and among the Stockholders, was entered into on December 18, 2003, with respect to the voting rights of the Subject Shares. In addition, pursuant to a Stockholders Agreement by and among Diane and Oudi Recanati and The Michael Recanati Trust, dated as of September 10, 2003, Diane and Oudi Recanati and The Michael Recanati Trust may be deemed to share the power to dispose of 577,469 shares held by Diane Recanati.

Diane, Oudi, Leon, Yudith Yovel, Ariel and Michael Recanati, by virtue of their positions as directors and officers of the Recanati Foundation, may be deemed to share the power to vote and dispose of 101,303 shares of Common Stock through the Recanati Foundation.

Oudi Recanati holds options for 10,500 shares of Common Stock under the Issuer's Non-Employee Directors Stock Option Plan.
