**Item 1.01 Entry into a Material Definitive Agreement.**

On January 5, 2009, Proliance International, Inc. (the Company ) entered into the Fifteenth Amendment (the Fifteenth Amendment ) of the Credit and Guaranty Agreement (as amended prior to January 5, 2009, the Agreement ) by and among the Company and certain domestic subsidiaries of the Company, as guarantors, the lenders party thereto from time to time (collectively, the Lenders ), Silver Point Finance, LLC ( Silver Point ), as administrative agent for the Lenders, collateral agent and as lead arranger, and Wells Fargo Foothill, LLC ( Wells Fargo ), as a lender and borrowing base agent for the Lenders.

Pursuant to the Fifteenth Amendment, and upon the terms and subject to the conditions thereof, the reduction of the Southaven Insurance Proceeds Reserve from \$5,000,000 to \$2,500,000, contained in Section 2.23 of the Agreement, has been extended from January 5, 2009 to January 20, 2009.
