Item 5.02 Departure of directors or principal officers; election of directors; appointment of certain officers; compensatory arrangements of certain officers.

(e) On April 12, 2010, the Compensation Committee of the Board of Directors of Majesco Entertainment Company (the Company) approved the terms of an incentive bonus plan for the Company's 2010 fiscal year. A description of the material terms of the 2010 Incentive Bonus Program applicable to the Company's executive officers is set forth in Exhibit 10.1 of this current report.

Item 5.07 Submission of Matters to a Vote of Security Holders.

(a) The annual meeting of the Company's shareholders (Annual Meeting) was held on April 12, 2010.

(b) At the Annual Meeting, shareholders of the Company voted to approve the election of Laurence Aronson and Keith McCurdy as Class II Directors of the Company. In addition, the shareholders voted to ratify the appointment of Amper, Politziner & Mattia, LLP (Amper) as the Company's independent public accountant for the fiscal year ending October 31, 2010. With respect to the election of Mr. Aronson, 10,247,263 votes were cast in favor, and 339,585 votes were withheld. With respect to the election of Mr. McCurdy, 10,459,826 votes were cast in favor, and 127,002 votes were withheld. With respect to the ratification of Amper as the Company's independent public accountant, 24,925,365 votes were cast in favor of ratification, 445,741 votes were cast against ratification, and 29,583 votes were withheld.
