The 2011 Annual Meeting of Stockholders of Green Dot Corporation will be held on June 2, 2011 at 10:00 a.m. (Pacific Time) at the DoubleTree Hotel Monrovia-Pasadena, 924 W. Huntington Drive, Monrovia, California 91016.

Proposals to be voted on at the meeting are listed below along with the Board of Directors recommendations. The Board of Directors recommends a vote **FOR** each of the nominees listed in Proposal 1, **FOR** Proposals 2 and 4 and every **3 YRS** for Proposal 3:

1. The election of two Class I directors of Green Dot Corporation, each to serve until the third annual meeting of stockholders following the 2011 annual meeting of stockholders and until his successor has been elected and qualified or until his earlier resignation or removal: 01 - Ross E. Kendell 02 - William H. Ott, Jr.
2. The approval of a non-binding advisory resolution on executive compensation.
3. Non-binding advisory vote on the frequency of future advisory votes on executive compensation.
4. The ratification of the appointment of Ernst & Young LLP as the independent registered public accounting firm of Green Dot Corporation for the year ending December 31, 2011.
