**ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT.**

On September 1, 2006, EGL, Inc., a Texas corporation (the Company), paid the following bonuses to the Company's executive officers under the Company's 2005 Incentive Bonus Plan for Executive Management Employees (the Cash Bonus Plan) with respect to the second quarter of 2006: E. Joseph Bento, President and Chief Marketing Officer, \$30,725.66; Ronald E. Talley, President SCG, \$29,496.56; Dana A. Carabin, General Counsel and Secretary, \$31,250; Charles Leonard, Chief Financial Officer, \$30,330.72.
