("Elliott International"), and Elliott International Capital Advisors Inc. ("International Advisors" and collectively with Elliott Associates and Elliott International, the "Reporting Persons"). Paul E. Singer ("Singer"), Elliott Capital Advisors, L.P., a Delaware limited partnership ("Capital Advisors"), which is controlled by Singer, and Elliott Special GP, LLC, a Delaware limited liability company (Special GP), which is controlled by Singer, are the general partners of Elliott. Hambleton, Inc. ("Hambleton") is the general partner of Elliott International. International Advisors is the investment manager for Elliott International. International Advisors expressly disclaims pecuniary interest in any Common Stock.

Elliott Associates beneficially owns 2,758,925 shares of Common Stock consisting of: (i) 1,130,616 shares of Common Stock, and (ii) preferred stock of the Issuer (Preferred Stock) convertible into 1,628,309 shares of Common Stock.

Elliott International and International Advisors together beneficially own 4,138,381 shares of Common Stock consisting of (i) 1,695,925 shares of Common Stock held by Elliott International, and (ii) Preferred Stock convertible into 2,442,456 shares of Common Stock.

Elliott Associates, Elliott International and International Advisors together beneficially own an aggregate of 6,897,306 shares of Common Stock.

(b) Percent of class:

Elliott Associates' beneficial ownership of 2,758,925 shares of Common Stock constitutes 2.7% of all of the outstanding shares of Common Stock.

Elliott International and International Advisors' aggregate beneficial ownership of 4,138,381 shares of Common Stock constitutes 4.3% of all of the outstanding shares of Common Stock.

Elliott Associates, Elliott International and International Advisors' aggregate beneficial ownership of 6,897,306 shares of Common Stock constitutes 6.6% of all the outstanding shares of Common Stock.
