Item 2.06 Material Impairments

On August 21, 2013, Monongahela Power Company (“MP”) and The Potomac Edison Company (“PE” together with MP, the “Companies”), both indirect wholly-owned subsidiaries of FirstEnergy Corp. (“FE”), entered into and filed a Joint Stipulation and Agreement for Settlement (the “Settlement Agreement”) with the majority of the parties to the Companies' generation resource transaction proceeding to propose and recommend that the Public Service Commission of West Virginia (the “PSC”) approve the transaction as modified by the terms and conditions of the Settlement Agreement.

Under certain of the terms and conditions of the Settlement Agreement, MP would acquire the remaining ownership of the Harrison Power Station from Allegheny Energy Supply Company, LLC (“AES”), an indirect wholly owned subsidiary of FE, and sell its minority interest in the Pleasants Power Station to AES for a net payment by MP to AES of approximately \$1.1 billion and MP's assumption of a \$73.5 million pollution control note.

As a result of the entry into the Settlement Agreement, FE and the Companies have concluded that, upon PSC approval of the Settlement Agreement without modification and the closing of the proposed transaction, MP and FE will be required to record impairment charges to reduce the net book value of the Harrison Power Station to the amount that is permitted to be included in jurisdictional rate base. Based on the terms and conditions of the Settlement Agreement, the impairment charge is anticipated to be approximately \$330 million (\$196 million after-tax). This charge is expected to reduce FE's basic earnings per share of common stock by \$0.47 for the period in which the transaction is consummated. If approved by the PSC, as requested in the Settlement Agreement, the transaction would likely close in the third quarter or early in the fourth quarter of 2013. The impairment charge is not expected to result in future cash expenditures for FE.

The terms and conditions of the Settlement Agreement are contingent upon the PSC's approval of the Settlement Agreement without modification and the subsequent closing of the proposed transaction. FE and the Companies can provide no assurance that the Settlement Agreement will be approved by the PSC without modification or at all.

Actual results may differ materially due to: the speed and nature of increased competition in the electric utility industry, in general, and the retail sales market in particular; the impact of the regulatory process on the pending matters before the Federal Energy Regulatory Commission and in the various states in which we do business including, but not limited to, matters related to rates and pending rate cases; the uncertainties of various cost recovery and cost allocation issues resulting from the realignment of American Transmission Systems, Incorporated into PJM Interconnection LLC; economic or weather conditions affecting future sales and margins; regulatory outcomes associated with storms, including but not limited to Hurricane Sandy, Hurricane Irene and the October snowstorm of 2011; changing energy, capacity and commodity market prices including, but not limited to, coal, natural gas and oil, and availability and their impact on retail margins; the continued ability of our regulated utilities to recover their costs; costs being higher than anticipated and the success of our policies to control costs and to mitigate low energy, capacity and market prices; other legislative and regulatory changes, and revised environmental requirements, including possible greenhouse gas emission, water discharge, water intake and coal combustion residual regulations, the potential impacts of Cross-State Air Pollution Rule, Clean Air Interstate Rule, or CAIR, and/or any laws, rules or regulations that ultimately replace CAIR, and the effects of the Environmental Protection Agency's Mercury and Air Toxics Standards rules including our estimated costs of compliance; the uncertainty of the timing and amounts of the capital expenditures that may arise in connection with any litigation, including New Source Review litigation or potential regulatory initiatives or rulemakings (including that such expenditures could result in our decision to deactivate or idle certain generating units); the uncertainties associated with the deactivation of certain older regulated and competitive fossil units including the decision to deactivate the Hatfield's Ferry and Mitchell Power Stations, the impact on vendor commitments, and the timing thereof as they relate to, among other things, Reliability Must-Run arrangements and the reliability of the transmission grid; adverse regulatory or legal decisions and outcomes with respect to our nuclear operations (including, but not limited to the revocation or non-renewal of necessary licenses, approvals or operating permits by the Nuclear Regulatory Commission or as a result of the incident at Japan's Fukushima Daiichi Nuclear Plant); adverse legal decisions and outcomes related to Metropolitan Edison Company's and Pennsylvania Electric Company's ability to recover certain transmission costs through their Transmission Service Charge riders; the impact of future changes to the operational status or availability of our generating units; the risks and uncertainties associated with litigation, arbitration, mediation and like proceedings, including, but not limited to, any such proceedings related to vendor commitments; replacement power costs being higher than anticipated or inadequately hedged; the ability to comply with applicable state and federal reliability standards and energy efficiency and peak demand reduction mandates; changes in customers' demand for power, including but not limited to, changes resulting from the implementation of state and federal energy efficiency and peak demand reduction mandates; the ability to accomplish or realize anticipated benefits from strategic and financial goals including, but not limited to, the ability to reduce costs and to successfully complete our announced financial plans designed to improve our credit metrics and strengthen our balance sheet, including but not limited to, proposed capital raising and debt reduction initiatives, the proposed West Virginia asset transfer and potential sale of non-core hydro assets; our ability to improve electric commodity margins and the impact of, among other factors, the increased cost of fuel and fuel transportation on such margins; the ability to experience growth in the Regulated Distribution segment and to continue to successfully implement our direct retail sales strategy in the Competitive Energy Services segment; changing market conditions that could affect the measurement of liabilities and the value of assets held in our nuclear decommissioning trusts, pension trusts and other trust funds, and cause us and our subsidiaries to make additional contributions sooner, or in amounts that are larger than currently anticipated; the impact of changes to material accounting policies; the ability to access the public securities and other capital and credit markets in accordance with our announced financial plan, the

cost of such capital and overall condition of the capital and credit markets affecting us and our subsidiaries; actions that may be taken by credit rating agencies that could negatively affect us and our subsidiaries' access to financing, increase the costs thereof, and increase requirements to post additional collateral to support outstanding commodity positions, letters of credit and other financial guarantees; changes in national and regional economic conditions affecting us, our subsidiaries and our major industrial and commercial customers, and other counterparties including fuel suppliers, with which we do business; issues concerning the stability of domestic and foreign financial institutions and counterparties with which we do business; the risks and other factors discussed from time to time in our Securities and Exchange Commission filings, and other similar factors.
