The Company previously announced on September 20, 2006, in connection with the public release of second quarter financial information, that an independent committee of its Board of Directors was carrying out a review of the Company's stock option grants and procedures. The review is substantially complete and the Company does not expect to make any material adjustments to its previously reported financial results for any periods. The Company expects to report further with respect to the special committee's review no later than its Form 10-Q filing.

The registrant's Quarterly Report on Form 10-Q for the period ended August 26, 2006 could not be filed within the prescribed time period because additional time was required in order to permit the registrant to complete the preparation of the Form 10-Q and the Company's independent auditors to complete their review with respect to the Form 10-Q.
