ITEM 1.01 ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT.

On July 28, 2008, Apogee Technology, Inc. (Apogee) received \$120,000 in proceeds from the sale of four promissory notes. Annette Jaynes, employee of the Corporation, loaned the company \$10,000 pursuant to the promissory note attached hereto; David Meyers, employee of the Corporation, loaned the company \$10,000 pursuant to the promissory note attached hereto; Herbert M. Stein, the Chairman and Chief Executive Officer of Apogee, loaned the Company \$50,000 pursuant to the promissory note attached hereto; and David Spiegel, a large shareholder of Apogee s common stock, loaned the Company \$50,000 pursuant to the promissory note attached hereto. The promissory notes bear simple interest of 8% per year and are to be repaid in cash after 180 days.

The promissory notes are attached hereto as Exhibit 99.1, Exhibit 99.2, Exhibit 99.3, and Exhibit 99.4 and are incorporated herein by reference.

ITEM 2.03 CREATION OF A DIRECT FINANCIAL OBLIGATION OR AN OBLIGATION UNDER AN OFF-BALANCE SHEET ARRANGEMENT OF THE REGISTRANT.

ITEM 3.02 UNREGISTERED SALES OF EQUITY SECURITIES

Associated with the promissory notes discussed above are four warrants. Each warrant is a three (3) year warrant with a strike price of \$1. The warrants represent 1,000; 1,000; 5,000 and 5,000 shares of common stock, for Ms. Jaynes, Messrs. Meyers, Stein and Spiegel, respectively, as added consideration for the Notes. These warrants, and the warrants previously issued to Messrs. Stein and Spiegel pursuant to earlier promissory notes, have been documented using the form of warrant, Exhibit 99.5, attached.
