MTS Announces Subscriber Growth Numbers for February 2009

Moscow, Russian Federation Mobile TeleSystems OJSC (MTS NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached **91.77 million users on February 28, 2009**.

During February, MTS consolidated subscriber base increased by 0.4 million subscribers with 340 thousand subscribers added in Russia.
