The shares vest in three (3) annual installments from the date of grant. Twenty five percent (25%) of the shares vest upon the first and second anniversary, the remaining fifty percent (50%) vests on the third anniversary of the date of grant.
- This number includes 148,276 restricted shares awarded pursuant to the amended and restated 2002 Non-Employee Director Stock Plan.
- (2) These shares remain subject to forfeiture and are nontransferable until vested. The shares vest over either three (3) or four (4) years from the date of grant.
