**EXPLANATORY NOTE**

This Amendment No. 9 to Schedule 13D ( Amendment No. 9 ) relates to the common shares of beneficial interest, no par value ( Common Shares ) of Western Asset/Claymore Inflation-Linked Opportunities & Income Fund (the Issuer ). This Amendment No. 9 is being jointly filed by Cascade Investment, L.L.C. ( Cascade ) and William H. Gates III (collectively, Reporting Persons ) to amend and supplement the Items set forth below on the Schedule 13D previously filed with the Securities and Exchange Commission on January 9, 2006, as amended on May 3, 2006, September 29, 2008, April 22, 2009, May 1, 2009, July 14, 2011, August 9, 2011, August 17, 2011 and December 9, 2011.

**Item 3. Source and Amount of Funds or Other Consideration**

During the past sixty days, Cascade acquired 79,539 Common Shares pursuant to a dividend reinvestment plan of the Issuer on the dates and at the prices and amounts set forth below. These acquisitions, together with previous shares purchased and received pursuant to the Issuer's dividend reinvestment plan, resulted in a 1% change in ownership from the last amount reported by the Reporting Persons on Schedule 13D.

Other than the reinvestment of the dividends, Cascade paid no consideration to acquire these shares.
