Item 8.01 Other Events

On November, 19, 2007, Public Service Company of New Mexico ("PNM"), a wholly owned subsidiary of PNM Resources, Inc. ("PNMR"), filed rebuttal testimony of several witnesses with the New Mexico Public Regulation Commission ("NMPRC") challenging the opposition to PNM's request to increase electric rates.

A brief summary of PNM's arguments regarding return on equity and reinstatement of a fuel and purchased power cost adjustment clause, as well as testimony of selected witnesses, will be posted as soon as possible on PNMR's Web site at www.PNMResources.com. None of the contents of the Web site are made part of this Form 8-K.

These witnesses include Jeffrey E. Sterba, Chairman, President and Chief Executive Officer, as PNM's main policy witness, and witnesses addressing certain fuel clause considerations, rate of return and overall cost of service. In general, PNM's rebuttal testimony argued that the Staff and Intervenor recommendations did not justify disallowance of a fuel clause because PNM meets the requirements for a fuel clause established in New Mexico law. In addition, PNM argues that it is entitled to a rate increase of approximately \$77.3 million, after adjusting for arguments of Staff and Intervenor with which PNM agrees.

PNMR and PNM are unable to predict the outcome of this matter.
