Vesting start date is July 11, 2012.
  - (2) Vesting of GSU grant of which was previously reported in Form 4.
  - (3) 1/48th of GSUs shall vest on the 25th day of the first month after the vesting start date (July 6, 2011) and an additional 1/48th will vest monthly thereafter until the units are fully vested, subject to continued service on such vesting dates.
