(the "Spin-off") that were granted to the Reporting Person pursuant to an equity plan of Time Warner Inc. and were forfeited in connection with the Spin-off. 3,400 restricted stock units will vest on October 1, 2015 and 7,517 restricted stock units will vest on October 1, 2016.
