- These stock options represent up-front equity grants covering four years of equity compensation for this named executive officer (2019 through 2022) and have been designed such that: (a) overall equity compensation expense on an annualized basis, and overall dilution, are
- both expected to be lower than if the Company had continued with the previous equity compensation program for four additional years; (b) the named executive officer will be incented to achieve the Company's business objectives over the four-year period; and (c) vesting is heavily weighted toward the end of the four-year period, in order to aid in retention over that timeframe.
 - Exercise price is equal to 115% of the closing price for the Company's common stock on the date of grant.
 - This award will cliff vest (100%) on March 15, 2023.
 - These stock options will vest in equal one-third installments on March 15, 2021, 2022 and 2023.
