If at any time prior to the 24 month anniversary of the Effective Date, the volume-weighted average of the Company's Common Stock closing price for 20 consecutive trading days (i) exceeds \$30, the number of shares that will vest upon the vesting date shall be 125% of the above amount and (ii) exceeds \$35, the number of shares that will vest upon the vesting date shall be 150% of the above amount.
