Notwithstanding the foregoing, in the event a Change of Control (as defined in Mr. Erdman's Employment Agreement) occurs during the term of Mr. Erdman's employment and Mr. Erdman's employment is terminated without Cause (as defined in Mr. Erdman's Employment Agreement) following such Change of Control, twenty-five percent of any unvested stock options that have not yet vested as of the date of such termination shall be deemed fully vested as of such date.
