**Breakthrough Television Series "The Tudors" Earns Two Emmy® Award Nominations for Showtime, Peace Arch® Entertainment
and TM Productions**

TORONTO July 17, 2008 -- Peace Arch® Entertainment Group Inc. The nominations are for "Outstanding Costumes for a Series" and "Outstanding Casting for a Drama Series" for the second season of the critically acclaimed program.
