- (1) Mr. Elshaw did not sell any of the reported 6,516 shares. Rather, this amount represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of withholding taxes due upon the 1/10/10 vesting of 16,199 of the 48,600 shares of restricted stock Mr. Elshaw was granted on 12/8/08. These withheld shares are not sold on the open market and become Revlon, Inc. treasury shares.
- (2) Of the 62,995 shares beneficially owned, (a) 11,867 shares are unvested restricted shares that the reporting person was granted on 12/10/07, which vest on 1/2/11; and (b) 32,401 shares are unvested restricted shares that the reporting person was granted on 12/8/08 which vest in substantially equal installments on 1/10/11 and 1/10/12.
