- (2) Represents shares of restricted stock previously granted to the reporting person by Issuer that were cancelled as of the Effective Time of the merger on May 24, 2011 of the Issuer and Purchaser, pursuant to which the Issuer survived the merger and became a wholly-owned subsidiary of Flowers ("Merger"). In connection with the Merger, these shares of restricted stock were cancelled in exchange for the right to receive a payment of \$4.00 per share, net to the reporting person in cash, without interest and less any required withholding taxes.
