- (1) On January 21, 2016, Willing L. Biddle (the "Reporting Person") sold 16,250 shares of Class A Common Stock to Urstadt Property Company, Inc. ("UPCO"), a Delaware corporation, of which the Issuer's Chairman, Charles J. Urstadt, is Chairman and a controlling shareholder, in a private transaction.
- (2) On January 22, 2016, the Reporting Person sold 6,250 shares of Class A Common Stock to UPCO, in a private transaction.
- (3) This figure includes 35,000 restricted shares of Class A Common Stock issued pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan.

Biddle, the Reporting Person's wife, and 555 shares are owned by the Catherine U. Biddle IRA for the benefit of Catherine U. Biddle.
