Strothotte, a director of the Issuer, on June 25, 2008 as restricted common stock, which were previously reported as held by Mr. Strothotte as nominee for Glencore Investment, and which upon vesting on June 25, 2009 have been issued directly to Glencore AG.

(3) The shares of common stock reported in Table I and Series A Convertible Preferred Stock reported in Table II are held directly by Glencore AG, a direct wholly-owned subsidiary of Glencore International AG, and indirectly by Glencore International AG and its controlling shareholder, Glencore Holding AG.

(4) Each share of Series A Convertible Preferred Stock is convertible into 100 shares of the Issuer's common stock at the times and under the circumstances described in the Certificate of Designation for the Series A Convertible Preferred Stock. The Series A Convertible Preferred Stock has no expiration date.
