(1) Represents the sale of 47,000 shares in 67 separate transactions, ranging from \$71.45 to \$72.44 per share, resulting in a weighted average sale price per share of \$71.831. The Reporting Person undertakes to provide upon request by the SEC staff, the Issuer, or a security holder of the Issuer, full information regarding the number of shares sold at each separate price within the range.

(2) Represents the sale of 4,200 shares in 25 separate transactions, ranging from \$72.47 to \$73.36 per share, resulting in a weighted average sale price per share of \$72.769. The Reporting Person undertakes to provide upon request by the SEC staff, the Issuer, or a security holder of the Issuer, full information regarding the number of shares sold at each separate price within the range.
