In the aggregate, the Reporting Persons beneficially own 1,427,320 shares of the Common Stock of the Issuer, representing approximately 5.08% of such class of securities. The beneficial ownership of each Reporting Person is as follows: (i) Fund beneficially owns 749,142 shares of Common Stock, representing approximately 2.67% of the class and (ii) Capital, as the investment adviser and sole general partner of the Fund and investment adviser to an account owned by a separate investment vehicle which holds shares of the Issuer's Common Stock, and Mr. Kolchinsky as the manager of Capital, each beneficially own 1,427,320 shares of Common Stock of the Issuer, representing approximately 5.08% of the class. The percentage of Common Stock beneficially owned by each Reporting Person is based on a total of 28,103,441 shares of Common Stock of the Issuer outstanding as of August 2, 2011.
