## Explanation of Responses:

- (1) On September 6, 2011, the Compensation Committee of the Board of Directors of United Natural Foods, Inc. (the "Company") reviewed the Company's financial performance in comparison to the targets established for the 25,000 performance shares awarded to the reporting person on March 14, 2011, which include the Company's earnings before interest and taxes and the average return on invested capital for the period from January 30, 2011 through July 30, 2011 (the "Performance Period"). The Compensation Committee thereby approved the vesting of 18,924 of the performance shares to the reporting person, with the remainder immediately forfeited, both of which were effective as of the last day of the Performance Period.
- (2) Following the Committee's determination regarding the vesting of the performance units described in footnote 1, the Company retained 7,986 shares of the shares issuable to the reporting person to satisfy the related tax withholding obligations based on the Company's closing stock price on the last day of the Performance Period.
