- (1) The total includes the acquisition of (i) 0.017391 shares on 10/13/09 which were received in lieu of cash under the Hewlett-Packard Company Dividend Reinvestment/Stock Purchase Plan ("DRIP") in a transaction exempt under Rule 16b-3, and (ii) 16.062100 shares on 10/07/09 through the broker's dividend reinvestment plan that operates on substantially similar terms to HP's DRIP thereby qualifying for the Rule 16a-11 exemption.
- (2) Each restricted stock unit represents a contingent right to receive one share of HP common stock.
- (3) As previously reported, on 04/20/09 the reporting person was granted 4,326 restricted stock units ("RSUs"), all of which will cliff vest on 04/20/10. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. There were 7.4330 dividend equivalent rights at \$45.96 per RSU credited to the reporting person's account on 10/07/09.
