Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 11.5330 dividend equivalent rights being reported reflect 11.5330 dividend equivalent rights at \$25.18 per RSU credited to the reporting person's account on 07/03/13.

(5) As previously reported, on 12/07/11 the reporting person was granted 15,000 restricted stock units ("RSUs"), 5,000 of which vested on 12/07/12, and 5,000 of which will vest on each of 12/07/13 and 12/07/14. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
