- (1) On September 19, 2006, Mr. Kispert received a grant of restricted stock units ("RSUs") covering shares of KLA-Tencor Corporation common stock. Following the completion of KLA-Tencor's fiscal year 2007, KLA-Tencor's Board of Directors determined that the number of shares of KLA-Tencor common stock subject to such RSU grant was 62,500. On September 19, 2008, Mr. Kispert vested in fifty percent (50%) of such RSUs.

- (2) Pursuant to the terms of the September 19, 2006 RSU grant, 11,384 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding.
- (3) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.
- (4) Does not include performance-based RSUs, if any, held by the Reporting Person for which an assessment has not yet been made regarding the achievement of the applicable performance goals. Any such holdings will be reported on Form 4 within two business days of the date such assessment is made.
