20,000 stock options with an exercise price of \$3.95 were granted on July 30, 2004. These options vest in two installments of 25% each (1) on the first and second anniversary of the grant date, and in eight subsequent quarterly installments of 6.25% each, commencing on October 30, 2006 and ending on July 30, 2008.

6,750 restricted stock units were granted on January 13, 2009. Each restricted stock unit represents a contingent right to receive one share (2) of common stock. The restricted stock units vest in four equal annual installments beginning January 13, 2010.
