- (1) These 7,572 shares of restricted stock were granted pursuant to the KAR Auction Services, Inc. 2009 Stock and Incentive Plan and were granted in two different grants on May 7, 2010. The first grant of 2,524 shares vested immediately on the date of grant. One-fourth of the second grant of 5,048 shares vests every three months from the date of grant (May 7, 2010) and such grant is subject to forfeiture until vested.
- (2) These shares of common stock were issued to the reporting person pursuant to the KAR Auction Services, Inc. 2009 Omnibus Stock and Incentive Plan in lieu of a quarterly cash retainer of \$12,500.
