Upon the occurrence of certain events, LTIP Units and OP Units are redeemable, without consideration, for an equivalent number of shares of Issuer's common stock or for the cash value of such shares, at Issuer's election.
- (2) LTIP Units vest one-half on January 13, 2012, with the remainder vesting one-third on each December 31 of 2012, 2013 and 2014.
